Kings Bay AREA RCM MARLCNA Report

JANUARY 17-19, 2025

The Interim World Service Conference is scheduled for February 28, and March 1st 2025 and Conference Agenda Report/Conference Approval Track document is out. Twelve Motions are listed, 6 by the World Board and 6-9 by the Co-Facilitators and 10-12 by the Human Resources Panel. No Regional Motions will be accepted until August 2025. Deadline for Amendments is February 13th. Delegates only will vote.

Related Motions for “Housekeeping” purposes:

Motion 1: *To adopt for the 2025 Interim WSC and the 2026 WSC only: If a motion has consensus in*

an initial straw poll (that’s 80% or more in support or not in support), the Cofacilitators will announce the results as a final decision. Paraphrase- Accept the initial straw poll consensus decision of a Motion as a final decision. The implications of this will be discussed in several online Regional CAR workshops and at MARLCNA January 17-19th .

Motions 2: Approve the 2023 Minutes.

Motions 3: Approve the 2025-26 World Budget. At the last cycle they did not know they would be going from a 2 year budget to a 3 year budget. They will use the base year as a foundation and adjust for an increase of 2.5% in contributions and increase of 7.5% for literature income, 11% increase in literature expenses and 5% increase in all other expenses. The decision to go from a 2 to 3 year cycle is for 6 years, 2023 to 2026 then 2026 to 2029 and then they will reevaluate.

Motions 4: To Keep the 2023 approved policy in place even though it was approved for a 2 year cycle and now we are in a 3 year cycle..

Motion 5: *To adopt for the current conference cycle only: The 2026 WSC will take a new step in Strategic Planning by using a revised process (described below) for the CAR survey to consider ideas for recovery literature, service material, and Issue Discussion Topics. Instead of submitting motions for project plans to create specific pieces of service material, recovery literature or IDTs for the 2026 Conference Agenda Report, conference participants will submit those ideas for possible inclusion in the 2026 CAR survey. Create the CAR survey celebratorily. Any member can submit a topic for the CAR survey*

Motion 6: Change the lead time for amendments from 15 to 45 days so there's more time to work with the motion maker.

Motion 7: Add a 30 day deadline to the policy for first drafts and a deadline of 15 days before the interim WSC.

Motions 8-9 are updates to the language in GWSNA cofacilitators use regarding amendments.

Motions 10-11 are regarding candidates considered for World Board nominations or World Pool nominations that should be put forward by Regions, Zones or World Board RZB process.

Motion 12 is to eliminate the World Seating Group for new Regions to be added to the Conference for this cycle.

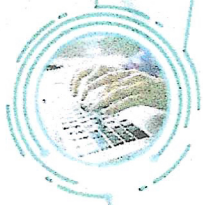
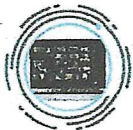
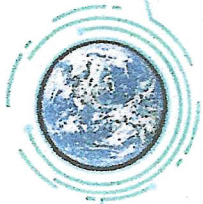
